If you need your quarterly rent statements produced in varying font sizes/printed on coloured paper, please contact your Housing Officer, named on your statement.

Most housing benefit payments are made in arrears. This may contribute to an arrears balance on your statement.

Any receipts made using our collection agency, **ALLPAY**, may show slightly different dates to those shown on your receipts, or in the case of direct debits, those shown on your bank statement. This is due to a short time delay in processing your payment to us. If this short delay results in an *arrears* balance, we will account for this.

Most transactions shown on your statement will be dated on the *Monday* of the relevant week.

Adjustments may show on your rent account, these can be for a number of reasons, e.g. your tenancy started before your account was processed and therefore no charge was raised during the first week of your residency. Also, if you had been charged after your tenancy ended, an adjustment will be made. Occasionally, rent levels & service charges may be adjusted. You will be advised by letter of any increases. More information can be provided on specific adjustments made on your account, please contact your Housing Officer, named on your statement.
